Use of Lodge:
The Lodge may be reserved for groups up to 30. Reservations can only be made by a member and all groups must have a member present at all times. The member making the reservation is responsible for the safety and behavior of guests and for any damages. A \$25 refundable damage deposit is required to hold a reservation. Those reserving the lodge must bring their own paper products, trash bags, and firewood. The reservations are for the lodge only, the grounds (and the parking) must be shared with other chapter members.

Rules of the Lodge and Grounds:

- Guests must be accompanied by a member of the Izaak Walton League, Bush Lake Chapter.
- Please send the usage fee to the chapter caretaker (same address as deposit).

Lodge:

- All visitors are requested to bring their own garbage bags, utensils, tableware, firewood, charcoal and accessories. There are occasionally excess paper plates, wood, charcoal and other disposable items for your use if you run short. Please replenish what you use.
- Toilet facility is located on the south end of caretaker home. Please keep clean, completely close the door (ensure it latches) when exiting the bathroom, and respect the caretaker's privacy.

Before Leaving:

- If heater is required, before leaving - ensure that the ***furnace and thermostat are turned off.***
- If fireplace (and/or firepit) is used, please ensure that the ***fire is completely extinguished.***
- Remove all garbage; sweep floors; return tables and chairs to location you found them; turn off lights; lock doors. Clean up member bathroom (adjoining caretaker's cabin).

Hours:

All members and guests should leave the property by 10pm unless a permit for extended hours has been issued by the board of directors. The chapter is a private property owner in a residential neighborhood and every effort should be made to keep noise and traffic to respectful levels.

Beach area:

The beach is unsupervised and all swimming is at your own risk. Parents are asked to closely watch their children and respect the rights of other swimmers and beach users. The beach area may not be reserved.

Dogs:

Dogs must be under control at all times. They should be leashed when other families are present, especially those with children. Dogs are not permitted in the beach area unless by special use authorized by the board. Dogs may be exercised in the area near the canoe racks or on the south shore area east of the beach. Dog owners are responsible for clean-up and proper disposal of pet waste.

Picnic tables and fire pits:

Tables, fire pits, and barbeques are on a first come, first served basis. Please be respectful and share with other members, particularly during high demand times. Picnic tables should remain on their concrete pads and fires kept in designated fire pit areas only. All fires must be fully extinguished before members and guests leave the property.

Sound:

The chapter is a private property owner in a residential neighborhood and every effort should be made to keep noise to respectful levels. ***Any human-generated sound which can be heard on adjacent properties is too loud.***
